TUITION INFORMATION

• TUITION PAYMENTS

The contract is secured with a deposit which is half of the first month's tuition. This deposit is applied to first month's tuition for all classes.

Tuition payments are due the 10th of each month.

Monthly payment plans must be secured with a credit card or bank draft.

TCS families are asked to maintain two forms of payment with the school to collect payments in a timely manner. (Visa, MC, and Am Ex are accepted. If paying by credit card, a 3.5% credit card administration fee will be assessed.)

Each family must set up a payment plan in the first week of school. All families, new and returning, must submit payment information every year.

• TUITION ASSISTANCE

The Children's School of Boise is committed to keeping the school accessible to as many families as possible. Tuition assistance is given on the basis of need. Applications are available on-line at www.solutionsbyyss.com. Select Login for families. The school's code is #4112. Please apply by January 31, 2025 so that awards can be considered prior to contract offerings for the 2025-2026 school year. • HOLIDAY CARE AND OCCASIONAL USE OF EXTENDED DAY

Children who need childcare during holiday breaks will register at those times for care. There will be an additional fee of \$90 per day for these days. Childcare days are available during Winter Break (January 2, 2026) and Spring Break (March 16-20, 2026)

Participation in occasional use extended day is billed at \$15 per hour or portion of hour. Priority is given to full time enrollment in extended day programs. Contact the office for occasional scheduling. Pricing sheet available upon request.

• CALENDAR 2025-2026

The Children's School year is either a nine-month program or a twelve-month program. The entire school is closed for 1 week every August (August 4-8, 2025). TCS closes for 4 conference days, 9 Federal holidays, November 24 – 28, 2025 for Autumn Break, December 22, 2025 – January 2, 2026 for the Winter Break, March 16-20, 2026 for Spring Break, August 3-7, 2026 and for occasional early release days. A 2025-2026 school calendar will be included with your contract.

• SUMMER PROGRAMS

Summer programs will be announced in February 2025.

All Day (12 month contract) classes continue at the regular monthly tuition.
